Action Items - for action at this Assembly meeting of September 19, 2023

A. <u>Items Automatically Placed on the Docket</u>

1. The Commission on Preparation for Ministry (CPM) and the Commission on Ministry (COM) recommend that the Presbytery Assembly approve Kimberly "Kim" Mendoza for ordination to the Ordered Ministry of Word and Sacrament, so that she may more fully accept the invitation to serve as a Pastoral Resident at First Presbyterian Church. Libertyville, IL.

Background: Kim Mendoza is a Candidate for Ministry, under the care of the Nevada Presbytery and the Session of the Henderson Presbyterian/Presbyterian Church of the Living God (two congregations currently undergoing a merger).

Kim has been Certified Ready to Receive a Call (CRRC) by Nevada Presbytery. Starting in January of 2022 Kim has been serving as a Pastoral Resident with First, Libertyville. The For Such A Time As This Pastoral Residency Program (FSATAT) was initiated by the PCUSA in 2013. The original intention was to support small-member congregations; mid-size and larger congregations also participated in this program. It allows for First-Call Candidates to be examined and ordained by presbyteries, to serve in a congregation as a Pastoral Resident for a period of two years and can be renewed (similar to an installed pastor serving for the designated period). Due to COVID-19 restrictions and other factors, this examination for ordination has been postponed until now.

The CPM of Chicago Presbytery has worked with Kim in preparation for this examination. The Staff and Session of First Libertyville have worked with Kim for nearly two years, and they fully support her call. Portions of her Personal Information Form (PIF) and Statement of Faith are in the meeting packet. The CPM and COM ask that the Assembly examine Kim for ordination, in support of her continued service at First, Libertyville.

2. The Presbytery Coordinating Commission (PCC) requests that the Assembly authorize the Presbytery Board of Trustees (aka members of the PCC) to approve the sale of the Morton Grove Community Church property, located at 8944 Austin Avenue, Morton Grove, IL, for a price not lower than \$1.3 million dollars.

Background: The Session and Congregation of Morton Grove Community Church (MGCC) have engaged in a visioning process to address their future mission and ministry in the Morton Grove community. This process included addressing the use of their current facility, the spiritual growth of their church community, outreach to the surrounding community, the reality of current membership numbers (currently 36 members), and the congregation's financial resources.

The Session and the Congregation were asked to consider and vote on one of three options, and Option # 2 was approved: "Transforming the congregation by reinvesting in programming and mission, with a full-time pastor and an anticipated sale of the church and a move to a new space by the year 2025."

The Session has worked closely with the Presbytery Staff, and our partners in property matters – Foundry Commercial Real Estate, and POC property attorney Crystal Bush. The Admin Team and PCC have been aware of this process since January of 2023.

The property was listed for sale – and nine offers were forthcoming. The Session is currently reviewing the top two potential buyers and hope to bring a recommendation to the Congregation and the Presbytery in the next few weeks.

This enabling motion will allow the Presbytery Trustees to approve a final offer between now and the November 2023 Assembly meeting. The finances for the sale will be handled through the Presbytery Office and bank accounts. After deductions for Presbytery expenses, the remaining funds will be forwarded to the congregation, along with a request for a donation to the Presbytery for administrative overhead costs.

3. The Nominating Committee places the following individuals into nomination for election by the Presbytery Assembly, to serve in various entities of the Presbytery (Commission, Committees, Work Groups, and Teams) for the indicated class terms.

Background: The Nominating Committee continues to work diligently to ask individuals who feel the call to serve in various opportunities for service on the Commissions, Committees, Work Groups, and Teams of the Presbytery. If our presbytery were up to "full capacity" (with all entity positions filled) we would need over 170 individuals. Currently, we have around 115.

There continue to be many opportunities to serve. The Nominating Committee presents their nominations and requests the Assembly to elect

them. Nominations from the floor are in order, so long as the nominee has agreed to serve and has spoken with a Nominating Committee member.

Kim Mendoza - Statement of Faith - September 19, 2023

 I believe that God created us out of God's great Love. This Love is so great and must be shared, between Creator and creation, within creation. Nothing can separate us from this Love, not even sin. Through the Holy Spirit's guidance and wisdom, each individual is able to discern God's will for their life on earth to carry-out God's greater plan for Creation.

We see this Love In the fellowship of the Holy Trinity: Creator, Redeemer, and Sustainer. The Holy Trinity teaches Creation its purpose for life: to share in life together. As the Holy Trinity dances together in Love, humanity too is called to this intimate dance which brings forth the light that shines uniquely in each individual.

Through the sacraments of the Lord's Supper and Baptism, we celebrate this mutual-indwelling in Christian Fellowship as Christ's body. In the Lord's Supper, we gather at the Table, reminded of the sacrificial Love of Christ where all are welcome and fed. Through the sacrament of Baptism, we receive the gift of God's grace and are reminded of our own cleansing from sin and death as God's beloved children.

I believe Scripture is the inspired Word of God, which provides a steady foundation of our faith. Through the studying of the Holy Scriptures with the guidance of the Holy Spirit, we gain wisdom in how to respond to God's continued transformation in the world.

Therefore, as the Church is the Body of Christ on earth, I believe the Church is called to witness Christ's reconciling ministry on earth--a ministry that invites all to the table and actively seeks those in the margins.

Describe a moment in your recent ministry that you recognize as one of success and fulfillment.

Directing the programming for our Coffee House/Open Mic Night Fundraiser was a recent moment of fulfillment in ministry. My task was to create a hospitable environment by working with the two youth emcees and organizing the musicians/artists. By the end of the night, we were able to exceed our fundraising goal; however, the success was in the relationships that were cultivated, the people who were able to reconnect with one another, and the love for one another as we received and shared our gifts. People were both touched by songs, and amused by comedic acts. As many reflected, the event became a safe space for the youth and other newer congregants to share their God-given gifts.

I realize fulfillment is found when I witness the Holy Spirit move people to share their gifts openly and freely, and when I see the Church Body support each other in the act of sharing. I believe it is a privilege to witness others sharing their gifts in a community. Further, as members of Christ's body, we then have the opportunity to encourage one another in each other's calling, "stirring one another up in love." Thus, fulfillment in ministry is found when I am able to witness and help create space for the Holy Spirit to move people to share and develop their gifts and build relationships with one another.

Describe the ministry setting to which you believe God is calling you.

I am passionate about providing a space for them to be themselves and grow into the person God is calling them to be. Further, I realize the care of the future generation requires the effort of the whole Church, and seek to foster authentic community in congregations. Thus, I believe God has called me to the work of drawing out the songs of people's hearts and the congregational song of a church body. This song is a song which brings healing and solidarity, and we all have a part to play and sing.

PCC / CEB Trustees Meeting Actions and Information Items

(From the PCC Meeting of June 27, 2023)

- 1. PCC took action for Barbara Gorsky to serve as Moderator of PCC; David Thornton has accepted a new call in another Presbytery.
- 2. PCC reviewed the 2023 Financial Reports and is waiting patiently for the appointment and election of a new Treasurer.
- 3. A \$60,000 draw was made from our Northern Trust Account, to help with cash flow (Monthly draws were suspended for 2022 and early 2023, due to an underperforming stock market.).
- 4. BMO Harris Bank is closing the John Taylor Trust. POC is to receive a payment of approximately \$200,000, which will be reinvested with Northern Trust.
- 5. PCC heard reports of the Presbytery Assembly Planning Team, regarding preparation for the in-person Stated Presbytery Assembly set for Tuesday, September 2023. The Planning Team reported on the positive energy and successful Assembly meeting at First, Glen Ellyn, on May 16, 2023. The church generously covered the cost of the evening meal.
- 6. PCC reconstituted the Task Force for Presbytery Office relocation (current office lease expires in March 2024).
- 7. PCC heard reports of the successful dinner with all New Worshipping Communities pastors and other leaders 16 were in attendance.
- 8. Chicago Presbytery has been selected for a pilot program PC(USA) Flourishing Pathways program, which will continue to encourage and equip NWC development.
- 9. PCC approved a spending increase for Ecumenical and Inter-religious Work Group (EIRWG) to allow for financial assistance for members to attend the Parliament of the World's Religions, meeting in Chicago, in August 2023.

- 10.Barbara Wilson and Julie Peterson reported on their participation in the Board of Pension "Season of Rebuilding" Event. The current due's structure will face changes in March 2024. More information can be found at https://seasonofrebuilding.pensions.org
- 11.PCC heard reports from POC Committees, Commissions, Work Groups, and Task Forces, including Campus Ministry Task Force, COM, COM, CARE, NWCC, Mission, SDOP.
- 12.PCC, acting as the Board of Trustees of the Church Extension Board of the Presbytery of Chicago (CEB), received updates on property matters before the Presbytery:
 - a. Parkview Presbyterian Church property, Oak Park an offer was approved for \$460,000 from Case de Restauracion Familia. Further offers above \$400,000 were also approved, if needed.
 - b. Christ Presbyterian Church property, Hanover Park the property has now been conveyed to the Presbytery / Church Extension Board. The process for property tax exemption is in process.
 - c. Christ Presbyterian Church Manse sale for \$267,000 was approved, to Befirst Inc / Serhiy Baranovskyy.
 - d. The distressed property at 4038-4040 W Madison Street, Chicago, continues to cause stress. Updates from the attorneys suggest outstanding property tax payouts are estimated to be around \$372,000. Legal fees thus far are \$101,000. The Admin Team is seeking other alternatives to sell, donate, or otherwise dispose of this property.
 - e. Morton Grove Community Church, Morton Grove The congregation (55 members) continues to move toward the sale of this property, and a relocation and continuation of mission and ministry within the Morton Grove community.
 - f. First, Arlington Heights sale of the eastside parking lot was approved, pending action by the congregation.
 - g. Elk Grove Church, Elk Grove Village church held their final worship service in early June. Dissolution of the Congregation to come to the Assembly in September meeting.

(From the PCC Meeting of August 22, 2023)

- 1. PCC reviewed the report from the Campus Ministry Task Force, including the recommendation for future funding of the UIC Campus Ministry Group The Inclusive Collective, and the United Christian Ministry at Northwestern University. The matter was referred to the Mission Committee for further action and reporting back to PCC.
- 2. PCC elected Kathleen Bromley to serve as the Presbytery of Chicago Treasurer. Kathleen was introduced to the PCC and received a warm welcome.
- 3. PCC reviewed the 2023 January to June Financial reports, which are now up to date, thanks to the arrival of our new Treasurer, Kathleen Bromley. It was noted that the Per Capita contributions are a bit behind from this time last year.
- 4. PCC reviewed the first draft of the 2024 Presbytery Budget (Operations and Pass Through); this will be presented to the Assembly for a First Reading at the September 19, 2023, Assembly meeting.

- 5. PCC heard the report of the Planning Team, regarding plans for the September 19, 2023, Assembly meeting, and a look toward future meetings. The Nov 14, 2023, meeting will be held on Zoom. The February 27, 2024, Assembly meeting will be held at Elmhurst Presbyterian Church, Elmhurst.
- 6. EP Craig Howard formally introduced Jana Blazek as our new Director of Connectional Relationships, a joint position with the Synod of Lincoln Trails (25% with the Synod, and 75% with POC). Craig also formally introduced Kathleen Bromley as our new Treasurer.
- 7. PCC heard the report from New Worshipping Communities Committee (NWC). They continue to work with Dia Nuevo, Divine Redeemer, NEXT Ministries. An event, Dreams Come True" is scheduled for September 28, 2023. Seed Grants from 1001 Worshipping Communities (Presbyterian Mission Agency funding) have been received for Dia Nuevo and Divine Redeemer. POC has also been selected as a pilot presbytery to discern how to best foster emergerging ministries.
- 8. The Creation Care and Justice Ministries Committee will be sending out a survey to congregations, to explore what and where creation care and environmental ministries are happening in our congregations.
- 9. The Mental Health Committee continues to plan for the upcoming Suicide Prevention workshop on Sept 16, 2023, and the Minister's Retreat on Oct 22-23, 2023.
- 10. PCC heard the report on those attending the Parliament of the World's Religions, part of the Ecumenical and Inter-Religious Work Group (EIRWG), including the Declaration for Creation Care. Craig also shared his experience of study leave to Poland, with visits to the Reformed Churches and seminary in Poland.
- 11. The Mission Committee shared news of recent grants to churches and campus ministries.
- 12. A request for funding from First PC, Chicago was referred initially to the Mission Committee. Upon reflection the PCC will hold a special meeting to review this request.
- 13. The Commission on Anti-Racism and Equity (CARE) will hold a workshop as a Pre-Presbytery Assembly educational event on September 19, 2023, at 3:00.
- 14. The Commission on Ministry and Commission on Preparation for Ministry reported to PCC.
- 15. PCC, acting as the Board of Trustees of the Church Extension Board of the Presbytery of Chicago (CEB), received updates on property matters before the Presbytery:
 - a. Parkview Presbyterian Church property, Oak Park a closing date is scheduled for later September.
 - b. Hanover Park Manse the Trustees voted to approve the list of Legacy Gifts requested by the Session of the (now dissolved) Christ Presbyterian Church, Hanover Park.
 - c. Our distressed property at 4038-4040 Madison Ave continues to annoy. Admin Team members hope to meet with the local alderperson to discuss possible donation or other disposition of this property.

- d. Morton Grove Presbyterian Church is moving toward a sale of their property. An enabling motion was discussed by PCC and will be brought to the Assembly on the September 19, 2023, meeting.
- e. Elk Grove church property will soon be listed on the market.
- f. Ravenswood, Chicago is moving toward a sale of their property, with a relocation to another property in the general area. The listing for the sale will go up October 1, 2023.
- g. First Itasca is considering a sale of their property, and a relocation of their mission and ministry to another nearby property.
- 16. PCC, acting as the Board of Trustees of the Church Extension Board of the Presbytery of Chicago (CEB), received a document Process for the Sale of Property and Relocation of an Existing Congregation, which is used to explain this overall process. In recent months three POC congregations have engaged in this process.

Executive Presbyter Report

Craig Howard

- Craig noted that, while each congregation in our presbytery is at a different stage in our respective journeys, we've recently experienced an "earthquake" (i.e., pandemic) that has sent us reeling and permanently shifted our positions. However, the journey continues. We cannot return to where we were but we can adjust and recover.

For some, that will mean that their ministry will be shared or combined with others, or even that God has concluded this faithful work and it is time to look toward congregational legacy. We're all planting for new and fresh expressions of God's church.
